ABOUT CAMP

Youth Camps are operated by the Church of God Executive Offices located in Charlotte, NC, under the direct supervision of the State Youth and Discipleship Director along with the State Youth Board. A complete background check is conducted for every staff application that we receive. We reserve the right to make decisions which are in the best interest of camp as it relates to staff and camper environment. **Cabin Leaders are to be a minimum of 21 years of age for all camps. Please note the minimum age for all other works now varies by camp. HS camp workers must be at least 20 years old, MS camp workers must be at least 18 years old, and Junior camp worker must be at least 16 years old.** All workers must have an endorsement signature from their local Church of God pastor. All workers are required to attend the mandatory staff orientation prior to each camp. We do not discriminate on the basis of race, sex, or nationality.

FIRST AID

All medications will be checked in at the beginning of camp by the medical personnel. All prescriptions must come in its originally labeled container. By law, prescription medications can only be administered as prescribed. During the week of camp, the medical personnel will be administering the medications and will return all medications the last day of camp. Medications will be released to the driver as the student is dismissed from camp.

HOW MUCH DOES IT COST

A \$25.00 pre-registration fee must accompany your completed application in order for you to be officially pre-registered. Your camp fee is based on the date that your registration is completed.

Refund Policy: Cancellations will be honored if requested ***14 days prior to the actual camp start date.*** After that, all funds are only transferable. All refunds will be processed after camps end in July.

Insurance: We partner with parents to provide medical/injury insurance coverage for every child. Should medical attention be required, the parent/guardian will be notified as soon as possible with all important information. Safety for all campers is important to us. **Our insurance is secondary coverage.**

Freebies: All campers who register by **May 12th** will receive a free t-shirt. The \$25.00 deposit must accompany the application to be considered complete. Limit 1 t-shirt per summer camp season. PLEASE LIST THE CAMPER SHIRT SIZE WHEN FILLING OUT THE APPLICATION! Changing of t-shirt sizes when registering on opening day of camp will be by availability only.

Confirmation of Attendance: When the camper application is received, a letter of confirmation will be **emailed** with more camp information. Please make sure your email address is provided on your application. If you do not receive your confirmation email two weeks after sending your camp application, please call the office at 704.717.0506. (Check junk/spam folders for email.) Applications must be completed in their entirety in order to be processed.

DAMAGED/LOST ITEMS POLICY

We are not responsible for any personal items lost or damaged. Regrettably, we cannot mail lost items. Campers should carefully pack their bags and double-check their areas to avoid left items.

WNCCOG Youth Camp Code of Conduct

1. All Campers will be under the supervision of their Cabin Leader at all times and remain in designated student areas only.
2. Cell phones are allowed in designated areas and at designated times only. The Church of God is not responsible for cell phones, iPads, cameras, MP3 players, or other electronic devices brought to camp. Any of the above items brought to camp are brought at the full risk of the camper.
3. Alcohol, tobacco, ecigs/vaping devices, illegal drugs, and pornography are strictly prohibited. All medication brought to camp must be left with the camp medical personnel.
4. No fireworks, lighters, firearms, knives, items capable of projecting laser light, or other weapons are allowed.
5. Violence, in all of its forms, is prohibited at the WNC Church of God Youth Camps.
6. All campers are expected to attend all camp activities unless excused by the Head Cabin Leader.
7. All campers and workers must adhere to the dress code. In general, clothing deemed immodest or inappropriate for particular activities will not be allowed at camp. The following guidelines should be observed:

RECREATION: Bring play clothes (no tank tops, strapless tops or halter tops — shorts of modest length are allowed), swimsuit and cover-up (girls are encouraged to wear one-piece suits), and athletic shoes.

FOR EVENING WORSHIP (HS & MS Camps Only):
Clothing considered appropriate for normal Sunday evening and/or Wednesday worship/youth group should be worn to youth camp evening worship. This honors God by presenting oneself before Him as prepared for worship.
8. Everyone at camp will be expected to help keep the grounds and facilities clean. Dorm rooms will be inspected daily.
9. All automobiles are to remain parked until camp is dismissed. No one may leave the grounds without special permission from the Camp Director. This includes campers and staff.
10. No camper is to be out of his/her dorm after “lights out” or before “rise & shine.”

(Any breach of proper conduct or disregard of camp rules will result in disciplinary action. Serious or repeated infractions will result in dismissal from camp.)

2024 WNC COG Youth Camp Fact Sheet

CAMP CANTEEN & CAMP STORE:

Available throughout the day in all camps to sell refreshments. Camp shirts and novelty items will also be available for purchase. You will want to bring some spending money for this.

HEAD CHECK:

Every camper will be checked for head lice before he or she will be allowed to check in to his/her room. This process will be handled discreetly and professionally. However, anyone with head lice or nits will not be admitted to camp.

NO VISITORS AT CAMP:

In order to protect the safety of both campers and staff a safety measure in place is NO visitors will be allowed at WNCCOG Youth Camp without authorization of the state youth director.

CHECK-IN:

Registration/Check-in is from 1:00-3:00PM on the opening day of all Camps. Check in will include a TSA type luggage check.

CHECK- OUT :

High School Camp - June 21 at 9:30AM
Middle School Camp - June 28 at 9:30AM
Jr. Camp - July 4 at 9:30AM

MEDICINE AT CAMP:

Any necessary medications should be brought to camp in their original container. All medications will be kept in the medical station and administered from there. By law, prescription medications can only be administered as prescribed.

CELL PHONES AT CAMP

Campers are allowed to bring cell phones to camp. The camper assumes ALL liability for his or her cell phone while at camp. There will be certain times during the day and certain areas of campus where cell phone use will not be permitted. Any camper who takes a compromising picture of another camper or staff member and makes it public in any way may be subject to dismissal from camp. If the law is broken, the appropriate authorities will be notified. Headphones and/or earbuds are not allowed at camp. In the event a camper disregards this policy, camp staff may confiscate the phone until the end of camp. For safety purposes, in place of parents, charged with responsibility of a minor, we reserve the right to search private property, including cellular devices.

DISMISSAL FROM CAMP:

If a child breaks the camp rules, or is disobedient to leaders, and is dismissed early from camp, the parent is responsible to immediately retrieve that child from the property. If a child comes to camp with a group, and is dismissed early from camp and that child's parents are not able or willing to retrieve the child from camp, it is the responsibility of the local pastor, youth pastor/leader to immediately retrieve or arrange for the retrieval of the child from the property.

THINGS TO BRING

- Appropriate clothes for church (refer to the code of conduct)
- Appropriate clothes for recreation (you will get dirty!)
- Twin-sized bedding for bunks
- Towels and washcloths
- Toiletries (toothbrush, toothpaste, soap, shampoo, deodorant...)
- Plastic bag for dirty clothes
- Swimsuit
- Sweater/light jacket
- Water shoes (optional but definitely most helpful for kids camp)
- Tennis shoes (they will get dirty)
- Prescribed medication in original container and inside a zip lock bag
- Bible, notebook, and pen
- Spending money for concessions stand and camp store.
- Flashlight



THINGS NOT TO BRING

- Tobacco in any form, including e-cigs/vapes
- Non-prescribed drugs/medications
- Firearms, knives, weapons(Bible is ok :)
- Fireworks, lighters, laser pointers
- Pornography in any form
- Anything expensive



PLEASE NOTE

Anyone driving to camp will be expected to park his/her vehicle in the designated parking area. All vehicles must remain parked until the individual has checked out of camp. Once a camper has checked out of camp, he or she must immediately leave the property. Anyone leaving the campground without permission will be dismissed from camp.
